

CONTEST RULES & REGULATION

The Organiser & Contest Period

1. The PERADUAN F&N LEBIH NILAI LEBIH JIMAT DI **AEON** (“Contest”) is organised by F&N Beverages Marketing Sdn. Bhd. (“Organiser”).
2. The Contest is open to all residents of Malaysia aged 18 and above as of 16/08/2021 except employees and immediate family members of the Organiser’s affiliates, subsidiaries, advertising/PR agencies and suppliers.
3. The Contest starts from 00:00:00, 16/08/2021 and ends on 23:59:59, 15/10/2021 (“Contest Period”). The Organiser reserves the right to change, cancel, terminate or suspend the Contest at any time during the Contest Period without prior notice.
4. For the avoidance of doubt, cancellation, termination or suspension by the Organiser shall not entitle the Participants to any claim or compensation against the Organiser for any loss or damage suffered or costs and expenses incurred by the Participant either directly and/or indirectly arising from or in connection with the cancellation, termination or suspension of the Contest by the Organiser.

Qualifying Criteria & Submission of Entry

5. A minimum purchase of **RM15 (Ringgit Malaysia Fifteen)** of any participating F&N Beverages, Dairies and/or Chilled (“Product”) in a single receipt from any **AEON** outlets during the Promotion Period (“Receipt”) will entitle you to enter the Contest. The Organiser will assign one (1) winning chance for every RM15 (Ringgit Malaysia Fifteen) purchase amount of Products (refer Clause 12).
6. The Receipt comes in the form of printed receipts from point of sale systems. The Receipt must consist details of the Products purchase, date of purchase, purchase amount, receipt number and name and/or logo of the outlet (“Receipt Details”).
7. The contest submission method is via WhatsApp only. **Each Receipt is ONLY eligible to 1 (one) entry via WhatsApp.** The Organiser shall reserve the right to disqualify any WhatsApp entries with duplicated Receipt.
8. WhatsApp entry participation steps:
 - a. Write on the front of the Receipt your full name as per MyKad and MyKad number (“Personal Details”).
 - b. Snap 1 (one) clear and legible picture/image of 1 (one) Receipt complete with your Personal Details and Receipt Details (“Image”). Receipt Details must be clearly shown and legible in the Image.
 - c. Submit 1 (one) Image via WhatsApp from any number registered in Malaysia to **6018-228 3803** (“Entry”).
 - d. The Organiser WILL reply with an auto-reply acknowledgment message for each Entry received.
9. The Organiser will extract all Entries received for further processing. All entries received are subject to the Organiser’s verification. The Organiser in its absolute discretion reserves the right to reject, disqualify and/or forfeit any entries with unclear, illegible and incomplete picture/image, reprinted

Receipt and/or duplicated Receipt and/or containing more than 1 (one) Receipt and/or late entries (i.e: entries received after **23:59:59, 15/10/2021**) without the need to provide any prior notice to any party.

10. The Organiser shall reserve the right to request for evidence of the original Receipt [hardcopy] for verification and prize redemption. Failure to produce the original Receipt upon request will result in disqualification and prize forfeiture.
11. The Organiser reserves the right to forfeit their participation in the event that the Participant(s) do not comply with the Contest Rules & Regulations.
12. All qualified entries (“Qualified Entries”) received by the Organiser during the Contest Period will be assigned 1 (one) serial number for every RM15 (Ringgit Malaysia Fifteen) purchase amount of Products. A set of serial numbers will be allocated for the Qualified Entries starting from serial number “1”.

Prizes

13. There are 20 (twenty) Grand Prizes and one hundred (100) Consolation Prizes to be won throughout the Contest Period. The Prizes are:
 - a. 20 (Twenty) Grand Prizes consists of a RM1,000 worth of Touch ‘n Go eWallet credit each; and
 - b. 100 (One hundred) Consolation Prizes consists of a RM100 worth of Touch ‘n Go eWallet credit each.
14. **Grand Prizes:** The total serial numbers allocated to the Qualified Entries throughout the Contest Period will be tabulated which will then be divided by 20 (twenty) to derive the winning serial numbers for the Grand Prizes. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.
For example: If the total Qualified Entries serial numbers for the contest total up to 10005, 10005 will be divided by 20 which equal 500.25 which will be rounded down to 500. The multiplier winning serial number in this case is 500. 20 (Twenty) Qualified Entries assigned with serial numbers with multiples of 500 i.e.: 500, 1000, 1500, 2000 and so forth will be the selected finalists of the Grand Prizes.
15. **Consolation Prizes:** The total serial numbers allocated to the Qualified Entries throughout the Contest Period will be tabulated which will then be divided by 100 (one hundred) to derive the winning serial numbers for the Consolation Prizes. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.
For example: If the Qualified Entries serial numbers for the contest total up to 10005, 10005 will be divided by 100 which equal 100.05 which will be rounded down to 100. The multiplier winning serial number in this case is 100. 100 (One hundred) Qualified Entries assigned with serial numbers with multiples of 100 i.e. 100, 200, 300, 400, 500, 600 and so forth will be the selected finalists of the Consolation Prizes.

Prizes Redemption

16. The Organiser will contact all selected Prizes Finalists via WhatsApp to the mobile numbers from which the Organiser received in the Qualified Entries. Each selected Finalists will be given 1 (one) question to answer via WhatsApp. The selected Finalists must answer the question posted by the Organiser correctly in order to win the Prize. In the event a selected Finalist failed to answer the question correctly or failed to answer within the time stated in the WhatsApp, the selected Finalist will be

disqualified and replaced by the serial number Finalist subsequent to the serial number of the disqualified Finalist.

17. The Organiser will not be held liable in the event the selected Finalists cannot be contacted for whatever reasons.
18. The Organiser will require the Winners to submit via WhatsApp their Full Name, MyKad Number and Delivery Address for further identification and verification purposes.
19. Each Participant can only win 1 (one) Prize of the highest value throughout the Contest Period.
20. All prizes will be delivered to the Winners within 6 – 8 weeks from 15/10/2021 to the Delivery Address provided by the winners via WhatsApp. The Organiser reserves the rights to extend the timelines stated under this clause owing to reasons beyond the control of the Organiser.
21. All Winners must abide by the terms & conditions of the party(ies) arranging and/or providing for the prizes. The Organiser reserves the right to forfeit their Prizes in the event that the Winner(s) do not comply with the Contest Rules & Regulations and Prizes Terms & Conditions.

27. The personal data that you provide us may be disclosed to our service providers only for the aforementioned purposes. You are responsible for ensuring that the personal data you provide us is accurate, complete and not misleading and that such personal data is kept up to date. You may access and request for correction of your personal data and/or to limit the processing of your personal data,

In the event of any inconsistencies between the English version and the Bahasa Malaysia version of this Notice, the English version shall prevail over the Bahasa Malaysia version.

Rights of the Organiser
