

CONTEST RULES & REGULATION

The Organiser & Contest Period

1. The PERADUAN F&N LEBIH NILAI LEBIH JIMAT DI **TESCO/LOTUS'S** ("Contest") is organised by F&N Beverages Marketing Sdn. Bhd. ("Organiser").
2. The Contest is open to all residents of Malaysia aged 18 and above as of 09/08/2021 except employees and immediate family members of the Organiser's affiliates, subsidiaries, advertising/PR agencies and suppliers.
3. The Contest starts from 00:00:00, 09/08/2021 and ends on 23:59:59, 10/10/2021 ("Contest Period"). The Organiser reserves the right to change, cancel, terminate or suspend the Contest at any time during the Contest Period without prior notice.
4. For the avoidance of doubt, cancellation, termination or suspension by the Organiser shall not entitle the Participants to any claim or compensation against the Organiser for any loss or damage suffered or costs and expenses incurred by the Participant either directly and/or indirectly arising from or in connection with the cancellation, termination or suspension of the Contest by the Organiser.

Qualifying Criteria & Submission of Entry

5. A minimum purchase of **RM5 (Ringgit Malaysia Five)** of any participating F&N Beverages, Dairies and/or Chilled ("Product") in a single receipt from any **TESCO/LOTUS'S** outlets (in-store and online) during the Promotion Period ("Receipt") will entitle you to enter the Contest. The Organiser will assign one (1) winning chance for every RM5 (Ringgit Malaysia Five) purchase amount of Products (refer Clause 12).
6. The Receipt can come in the form of printed receipts from point of sale systems and/or e-receipts for online purchases. E-receipts for online purchases with promotion codes and/or discount vouchers must be with the final paid amount of RM5 (Ringgit Malaysia Five) and above to qualify. The Receipt must bear the Products purchase, date of purchase, purchase amount, receipt number and name and/or logo of the outlet ("Receipt Details").
7. The participation method is via WhatsApp only. **Each Receipt is ONLY eligible to 1 (one) entry via WhatsApp.** The Organiser shall reserve the right to disqualify any WhatsApp entries with duplicated Receipt.
8. WhatsApp entry participation steps:
 - a. Write on the front of the Receipt your full name as per MyKad and MyKad number ("Personal Details").
 - b. Snap 1 (one) clear and legible picture/image of 1 (one) Receipt complete with your Personal Details and Receipt Details ("Image"). Receipt Details must be clearly shown and legible in the Image.
 - c. Submit 1 (one) Image via WhatsApp from any number registered in Malaysia to **6018-228 3803** ("Entry").
 - d. The Organiser WILL reply with an auto-reply acknowledgment message for each Entry received.

9. The Organiser will extract all Entries received for further processing. All entries received are subject to the Organiser's verification. The Organiser in its absolute discretion reserves the right to reject, disqualify and/or forfeit any entries with unclear, illegible and incomplete picture/image, reprinted Receipt and/or duplicated Receipt and/or containing more than 1 (one) Receipt and/or late entries (i.e: entries received after **23:59:59, 10/10/2021**) without the need to provide any prior notice to any party.
10. The Organiser shall reserve the right to request for evidence of the original Receipt [hardcopy] for verification and prize redemption. Failure to produce the original Receipt upon request will result in disqualification and prize forfeiture.
11. The Organiser reserves the right to forfeit their participation in the event that the Participant(s) do not comply with the Contest Rules & Regulations.
12. All qualified entries ("Qualified Entries") received by the Organiser during the Contest Period will be assigned 1 (one) serial number for every RM5 (Ringgit Malaysia Five) purchase amount of Products. A set of serial numbers will be allocated for the Qualified Entries starting from serial number "1".

Weekly Prizes

13. There are a total of 23 (twenty three) Weekly Prizes to be won each week for 9 (nine) consecutive weeks throughout the Contest Period. The Prizes are:
 - a. 1 (One) Grand Prizes consists of a SAMSUNG GALAXY TAB S7 (LTE) worth RM3599 each;
 - b. 2 (Two) First Prizes consists of a TESCO/LOTUS'S Voucher worth RM500 each;
 - c. 20 (Twenty) Consolation Prizes consists of a TESCO/LOTUS'S Voucher worth RM50 each.There are a total of 9 (nine) Grand Prizes, 18 (eighteen) First Prizes and 180 (one hundred and eighty) Consolation Prizes to be won throughout the Contest Period.

15. Weekly Grand Prize and First Prizes: The serial numbers allocated to the Qualified Entries for each week will be tabulated which will then be divided by 3 (three) to derive the winning serial number for the week's Grand Prize and First Prizes. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.
For example: If the Qualified Entries serial numbers for the contest total up to 1501, 1501 will be divided by 3 which equal 500.33 which will be rounded down to 500. The multiplier winning serial number in this case is 500. 3 (Three) Qualified Entries assigned with serial numbers with multiples of 500 i.e.:
 - a. 500 will be the selected finalist of the Grand Prizes and;
 - b. 1000 and 1500 will be the selected finalists of the First Prizes.
16. Weekly Consolation Prizes: The serial numbers allocated to the Qualified Entries will be tabulated for each week which will then be divided by 20 (twenty) to derive the winning serial numbers for the week's Consolation Prizes. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.

For example: If the Qualified Entries serial numbers for the contest total up to 1501, 1501 will be divided by 20 which equal 75.05 which will be rounded down to 75. The multiplier winning serial number in this case is 75. 20 (Twenty) Qualified Entries assigned with serial numbers with multiples of 75 i.e. 75, 150, 225, 300, 375, 450 and so forth will be the selected finalists of the Consolation Prizes.

Prizes Redemption

17. The Organiser will contact all selected Prizes Finalists via WhatsApp to the mobile numbers from which the Organiser received in the Qualified Entries. Each selected Finalists will be given 1 (one) question to answer via WhatsApp. The selected Finalists must answer the question posted by the Organiser correctly in order to win the Prize. In the event a selected Finalist failed to answer the question correctly or failed to answer within the time stated in the WhatsApp, the selected Finalist will be disqualified and replaced by the serial number Finalist subsequent to the serial number of the disqualified Finalist.
18. The Organiser will not be held liable in the event the selected Finalists cannot be contacted for whatever reasons.
19. The Organiser will require the Winners to submit via WhatsApp their Full Name, MyKad Number and Delivery Address for further identification and verification purposes.
